STD/Syphilis Updates

Syphilis Updates Included in VDH Clinician Letter

On July 23, 2024, **VDH Commissioner Karen Shelton** published a letter to health professionals in Virginia sharing several important updates about syphilis in Virginia:

- Pfizer has alerted the U.S. Food and Drug Administration that it has available doses of Bicillin 2.4mu available for purchase, effectively ending the shortage that began in 2023.
- Cases of early syphilis and syphilis of late or unknown duration in Virginia increased 16% and 30%, respectively.
- Twelve cases of congenital syphilis have been identified so far in 2024, putting Virginia on track to exceed the number of cases identified in 2023 (21).
- Cases of early syphilis increasingly occur among patients who selfreport use of cocaine, methamphetamine, or opioids. In 2023, 11% of cases occurred among persons who reported use of one of these substances.
- Syphilis should be included in the differential diagnosis for clients in clients with neurological, ocular (eye), or otic (ear) complaints. These clinical manifestations of syphilis occur in 2-3% of cases and can occur at any stage.

Providers can help address increases in syphilis by prescribing DoxyPEP for patients who are clinically indicated, expanding testing in counties with elevated rates of syphilis, and following the Centers for Disease Control and Prevention (CDC) recommendations for serologic screening, staging, and treatment of syphilis.

Holistic and Syndemic Approaches for Disease Prevention

In April 2023, the Health Resources and Services Administration (HRSA) HIV/AIDS Bureau (HAB) issued a program letter on the role of Ryan White HIV/AIDS Program (RWHAP) in addressing sexually transmitted infections (STIs) and mpox. Since last year, the United States has continued to experience an increase in STIs, which significantly impacts people with HIV.

HRSA HAB has released a new program letter that provides information on the CDC's new clinical guidelines on the use of doxycycline post-exposure prophylaxis (doxyPEP) for prevention of bacterial STIs. DoxyPEP is a novel use of an STI medication for prevention that has demonstrated effectiveness in reducing the incidence of bacterial STIs in certain populations – specifically syphilis, chlamydia, or gonorrhea.

In the program letter, HRSA HAB recommends that RWHAP receipts adopt the CDC's doxyPEP guidelines to offer this new prevention intervention for populations who would likely benefit from this intervention. Specifically, they encourage the use of RWHAP funds to purchase doxycycline for eligible clients and for RWHAP Part B Drug Assistance Programs to add doxycycline to their formularies to ensure access and coverage.

As a reminder, the Virginia AIDS Medication Program (VA MAP) already includes doxycycline on its RWHAP formulary list.
