

BOND FORM FOR THOSE PERSONS REQUIRED TO HAVE INSTALLATION LICENSE  
FAUQUIER COUNTY WATER SUPPLY ORDINANCE

KNOW ALL MEN BY THESE PRESENTS, THAT \_\_\_\_\_,

principal, and \_\_\_\_\_, surety, are held and firmly bound unto The Board of Supervisors of Fauquier County, Virginia, and its assigns in the sum of \_\_\_\_\_ DOLLARS (\_\_\_\_\_), for the payment whereof, well and truly to be made, we, the said principal and surety, bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally, firmly by these presents:

WHEREAS, the said principal has applied for an "installation license" to engage in the installation and/or repair of individual well water supply systems, or parts thereof in Fauquier County, Virginia;

WHEREAS, said principal must operate under permits and in accordance with a certain ordinance entitled "Water Supply Ordinance of Fauquier County, Virginia" as applicable to installation and/or repair of said systems in Fauquier County, Virginia;

WHEREAS, it is the desire of the principal and surety hereunder to guarantee to The Board of Supervisors of Fauquier County, Virginia, that the conditions and requirements of a certain ordinance entitled "Water Supply Ordinance of Fauquier County, Virginia" be complied with as well as permits and specifications therefrom:

NOW THEREFORE, the conditions of this bond are such that if the above named principal shall comply with the terms of said license and indemnify and save harmless the said Board of Supervisors of Fauquier County, Virginia, as well as any person, firm or corporation, from all expense or damage that may be incurred by such, caused by any failure to comply with the provisions of the said "Water Supply Ordinance of Fauquier County, Virginia" or permits issued therefrom, and from all expense and damage that may be caused by any neglect, defective or inadequate work, then the above obligation to be void and of no effect, but in no event is the liability of the surety hereunder to exceed the amount of this bond.

This bond shall be in full and effect for a period of eighteen months from the date hereof, and further shall be in full force and effect until the expiration of six (6) months after the last installation, repair or work done under and by virtue of said license for which this bond is given.

The surety on any such bond may terminate its liability under such bond by giving thirty days written notice thereof, served either personally or by registered mail, to the principal and the Board of Supervisors of Fauquier County and to the Health Department; and upon giving such notice the surety shall be discharged from all liability under such bond for any act or omission of the principal occurring after the expiration of thirty days from the date of service of such notice.
