VDH Dental Health Program

Program activities include:

- Educational activities and resources to a wide variety of partner groups to promote proper oral hygiene and support prevention services and access to dental care to all Virginians
- Direct clinical preventive services and assistance with establishing a dental home
- Quality assurance reviews to assure a competent public health oral health workforce
- Surveillance and evaluation activities to monitor and track dental disease rates and trends and for program assessment and planning

Community Water Fluoridation Program

- Education and support to local waterworks operators to ensure proper water fluoridation
- Technical assistance on issues of fluoridation to citizens and communities
- Maintaining a Virginia fluoride monitoring system including monthly reports and community data
- Data is used to generate annual summary reports for CDC Population Census Reports and annual compliance awards and is uploaded to public websites: <u>Oral Health Maps</u> and <u>My Water's Fluoride</u>.

Bright Smiles for Babies Fluoride Varnish Program

- Eases barriers to care by providing preventive services such as oral health screenings, fluoride varnish and dental referrals in non-dental settings where parents of young children are seeking other services
- Trainings for public and private health professionals to raise awareness for early intervention and to equip with the knowledge and skills necessary to provide clinical preventive services

Disabilities and Chronic Conditions Oral Health Program

- Improve access to dental services for individuals with Disabilities and Chronic Conditions through a current web-based listing of over 2,300 dental providers, currently representing approximately 30% of licensed dental providers in Virginia
- Provide oral health presentations and educational materials for medical/dental professionals, dental/dental hygiene students, lay health workers, caseworkers, teachers, caregivers, etc.







Adult Oral Health and Chronic Disease Program



- Oral Health education for older adults and caregivers, linking oral health to overall health
- Oral Health education for training programs such as Medical Assistants, CHWs and other allied health professions
- Education and support of health care providers to integrate medical and dental services for whole person wellness through collaborative partnerships in safety net settings across Virginia

Oral Health Workforce Program

- Focus is underserved areas of Virginia facing workforce challenges
- Enhances data used by VDH and other stakeholders to inform programs statewide, improving oral health in underserved areas
- Mentorship, technical assistance, and grants promote and facilitate medicaldental integration by enabling safety net clinics in Dental HPSAs to improve equitable access to care

School Based Preventive Services Program

- Program is offered to high-risk schools that have at least 50% of their students participating in the National School Lunch Program; all students in grades Pre-K to sixth grade are eligible for preventive dental services
- Priority goal is to refer child to a local dentist for routine comprehensive care
- Parents receive a list of area dental practices/community clinics for referral for treatment needs and to assist in establishing a dental home





School Based Preventive Services Program

As of September 2023, eight health districts are supported by VDH remotesupervised dental hygienists:


