### VDH: 2024 Shelter Fundamentals Training - TRAIN Course ID #1120658 (On Demand)



This three-day course is designed for those emergency response/ Health Department personnel and community partners who would function in a Command or General Staff position during a large, complex incident or event or personnel who are or would likely be part of a local or regional Incident Management Team during a major incident, whether single agency, multi-agency or Unified Command. ## ICS- 400 Advanced Incident Command Location: Peninsula Health District 836 J Clyde Morris Blvd Newport News, VA 23601 Dates: November 18th- November 19th Class Hours: 8:00 am – 5:00 pm

ICS-400 provides training and resources for responders who require advanced application of the ICS by providing overall incident management skills rather than tactical expertise. Expanding upon information covered in ICS-100 through ICS-300 courses, ICS-400 emphasizes large-scale organizational development, roles and relationships of the command and general staff, and planning, operational, logistical, and fiscal considerations related to large and complex incident and event management. The course also describes the application of Area Command and the importance of interagency coordination on complex incidents and events.

## The Eight Step Exercise Design Process.... Step 5: Compose a Narrative

What is a narrative? Your narrative, or scenario, script, whatever you choose to call it is an outline, or model of the simulated sequence events of your exercise. They can be written in a paragraph (or narrative) form or timeline format. Are there differences between narrative for discussion based vs. operations-based exercises? You bet. For discussion-based exercises, the narrative provides the backdrop that drive participant discussions, whereas for operations-based exercises, a scenario provides a driver or catalyst for actions within the context of your exercise. Just remember, for operations-based exercises, the narrative is only a small portion, the reminder of your scenario plays out via the Master Scenario Events List (MSEL).

Step 3

Sten

What must my scenario or narrative contain? Well, scenarios must contain three basic elements. First being the general context or comprehensive story of the incident. Second, you must develop it to contain the

conditions sufficient for the players to demonstrate proficiency or guide them to discussions based on their plans, policies, and procedures. Do not develop your narrative until your purpose, scope, and objectives have been developed.

How much detail should I put into my narrative? Simply put, it should be developed to reflect realworld uncertainty and be designed to ensure that the scope of the exercise remains within your scope so that it can be implemented without being overwhelming and failing to test the desired plans, policies, and procedures and personnel.

Lastly, it never hurts to wargame your scenario within the context of the planning team to test for effectiveness in reaching the desired objectives and outcomes.

## **New HIPAA-Only Training For MRC Volunteers**

In July 2023, a new required course for all MRC volunteers, Cybersecurity/HIPAA Training was rolled out in TRAIN. Completion of this course impacted volunteer's ability to be deployed. However, as of July 8, 2024, only 16% compliance was achieved. Based on feedback and discussions with the Office of Information Management (OIM) Information Security Team and the HIPAA compliance officer, a HIPAA Only course is being developed that should only require about 15 minutes to complete. Once completed it will complete the current Cybersecurity/HIPAA training course. MRC volunteers that already completed the original course will NOT be required to complete the new course. New MRC volunteers must complete the new shorter HIPAA course as part of their onboarding process. MRC volunteers that have not completed this course will still be deployable but will need to complete his course as just-in-training during their next deployment.

Once the new HIPAA Training for MRC volunteers course is completed and approved by OIM Information Security Team and the VDH HIPAA Compliance Officer, an announcement will be sent out to MRC Unit Coordinators and MRC Volunteers. In the meantime, the current Cybersecurity/HIPAA training requirement for new and existing MRC volunteers remains in effect.

## MRC Statewide Radiological Health Response Team

In 2023, the Virginia MRC program rolled out the new MRC Statewide Radiological Health Response team to augment the VDH Office of Radiological Health's response to radiological emergencies in Virginia. Currently, we have 70 MRC volunteers fully trained, including 54 volunteers trained for the EAC Augmentation team role, 6 volunteers trained for the NPZ Monitoring Team role, and 10 MRC volunteers trained for both roles. Two of our statewide team members provided augmentation support to the VOPEX 2024 EAC exercise in Hanover County on July 16th as part of the decontamination team.
